★ *Main practice experiences:*

Lawyer Li Zonglin, a former university teacher and civil servant, is good at criminal defense, criminal and civil intersection, and resolution of difficult and complex commercial disputes. Main achievements in the past three years:

Criminal Defense:

1. A case of usury loans, collusive bidding, and forced trading of a group in Hubei (at the trial stage, the indictment was withdrawn, and he was not guilty);

2. Beijing Zhang Moumou's illegal business case (at the stage of review and prosecution, the facts are unclear and the evidence is insufficient, and the prosecution is not prosecuted, and he is not guilty);

3. Beijing Sun Moumou fraud case (at the stage of review and prosecution, the facts are unclear and the evidence is insufficient, and the prosecution is not prosecuted, and the crime is not guilty);

4. Guangdong Tao obstruction of official duties case (during the investigation stage, obtained bail pending trial, not transferred for review and prosecution, not guilty);

5. Cai Moumou and other cases involving evil in Inner Mongolia (second-instance stage, remanded for retrial);

6. Anhui Tianmou fraud case (the case with the largest number of acquittals in the first instance since the founding of the People's Republic of China, defending one of the defendants);

7. Beijing Fumoumou's case of illegally absorbing deposits from the public (at the stage of review and prosecution, it was decided not to prosecute);

8. Beijing Wei's case of helping information network criminal activities (the case supervised by the Ministry of Public Security and received a light sentence);

9. Shanxi Feng Moumou, Jiangxi Dai Moumou, Guangdong Lin Moumou and many other cases involving black crime;

10, Sichuan Yuan Moumou, Yunnan Yao Moumou, Shenyang Wang Moumou and many other intentional homicide cases defense.

Dispute Resolution:

1. Shi Moumou and Shougang Jingtang Group and China Sanye Group construction project construction contract dispute (won the retrial).

2. Dispute between a listed company and a group company, a financial leasing company, Zhang Moumou, etc. for harming the interests of the company (winning the lawsuit)

3. Zhang Moumou v. A Company Bankruptcy Claim Confirmation Dispute (Winning Case)

4. Liu v. Cen et al. Revocation (Winning Case)

5. Ye Moumou and a network technology service company contract dispute (winning lawsuit)

8. Li Moumou v. Qian Moumou and other workers' compensation case (accepted the entrustment after the plaintiff lost the lawsuit three times and won the lawsuit)
